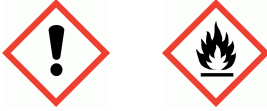

#### **SECTION 4: First aid measures**

##### **4.1. Description of first aid measures**

<b>General information</b>	Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Never give anything by mouth to an unconscious person. Get medical attention if any discomfort continues.

## **SECTION 5: Firefighting measures**

### **5.1. Extinguishing media**

**Suitable extinguishing media** Extinguish with the following media: Water spray, fog or mist. Foam, carbon dioxide or dry powder. Dry chemicals, sand, dolomite etc.

**Specific hazards** Vapours are heavier than air and may spread near ground and travel a considerable distance to a source of ignition and flash back. Risk of explosion if heated. Toxic gases or vapours.

### **5.3. Advice for firefighters**

**Protective actions during firefighting** Wear positive-pressure self-contained breathing apparatus (SCBA) and appropriate protective clothing. Cool containers exposed to flames with water until well after the fire is out. Control run-off water by containing and keeping it out of sewers and watercourses.
